TUITION ASSISTANCE APPLICATION FOR 2022-2023 SCHOOL YEAR

In order for the TDCA Tuition Assistance Committee to consider this application, all sections must be completed and the applicant must currently be in the Admissions Process (have applied for the 2022-2023 school year or attached the Application for Enrollment). All information on this application and all forms submitted are for the use of the Tuition Assistance Committee **ONLY** and will be treated in the strictest confidence. Our highest priority is in assuring the privacy and dignity of our current and prospective TDCA families and parents.

Tuition Assistance is only available for K-6 students and is not automatically renewed. Families must apply each year. The Tuition Assistance Fund is based on the generous donations of partners. These funds are raised on a yearly basis and can vary in amount from year to year. The committee welcomes any comments or additional information you would like considered.

AS FUNDS ARE LIMITED FOR TUITION ASSISTANCE, PRIORITY WILL BE GIVEN TO THOSE APPLICANTS PROVING FINANCIAL NEED AND COMMIT TO FOLLOWING THROUGH ON COMMITMENT OF PARENT VOLUNTEER HOURS.

NO LATE APPLICATIONS WILL BE CONSIDERED.

Applications for the 2022-2023 School Year are due no later than March 15, 2022.

All applicants will be notified by May 15, 2022 about the status of their application.

Available tuition assistance funds will be awarded based on the committee's evaluation of financial need and will be applied monthly to tuition invoices from August 2022 - May 2023.

Please make sure that you have included the following documentation with this application:

- **Copy of last three (3) months pay-stubs for both husband and wife, where applicable.**
- **Copy of most recent income tax return.**

I fully understand that my submission of this application represents acknowledgement of certain obligations on my part towards the school. I agree that should tuition assistance be awarded, I am hereby obligating myself to assist the committee or designated representatives in its efforts to raise sufficient funds to continue to disburse tuition assistance funds such as mine. Such assistance will take the form of my commitment to raise certain predetermined sums for the Financial Aid Fund and/or participate in various fund-raising projects organized by the school. Depending on the amount of tuition assistance offered, my family agrees to completing the parent volunteer hours as part of our commitment to bless and strengthen the children and families at TDCA.

Tuition Assistance Levels that are awarded to families pending the decision of the Tuition Assistance Committee: (Each family is awarded only one level of tuition assistance and agrees to each level of parent helper hours as this family’s responsibility to complete these volunteer hours at TDCA).

I further agree that if there is any change in the information contained herein (increase in income, spouse becoming gainfully employed, etc.) that I will notify the Tuition Assistance Committee. As a result of said change, or if the committee becomes aware of some material discrepancy between the information submitted herein and the facts, the committee may revoke all or part of this tuition assistance at their discretion and I agree that they may add that amount to my tuition obligation.

I understand that Tuition Assistance is a year-long agreement based on a partnership between TDCA and the respective family. In the event of not honoring the commitment agreed upon, the Tuition Assistance may be revoked and the family will be responsible for the remaining tuition balance of the remaining months of school. Tuition Assistance does not cover registration fees or ancillary fees including supply fees, field trips, etc.

Those who receive Tuition Assistance commits to fulfilling the required number of hours each month. You can work ahead to fulfill hours, but if the family is not on the required pace for two months, the tuition assistance is forfeited, and the billing will be for full tuition on the next month. In order to receive tuition assistance again, the family will need to be fully caught up in parent volunteer hours through the current month, to receive Tuition Assistance for the following month.

Each family needs to be on pace for the required number of hours/month. You can work ahead, but the pace must be met by the end of each month in order to continue to receive Tuition Assistance for the following month.

For example,

If a family has received Level 2 Tuition Assistance (\$150/month, and required to serve 30 parent volunteer hours), the family would be required to have served 3 hours/month for each month.

If the family served 3 hours in August and September, but then did not complete the 3 hours in October and November (for a total of 12 hours by November 30th), the family would be billed for the full tuition in December. If the family completed 15 hours by December 31st, the family could receive Tuition Assistance in January and would need to continue to keep on pace in order to receive Tuition Assistance.

If any TDCA family does not complete the required 15 P3 hours for the year, there is a \$200 penalty charged to your PaySimple Account in May.

Recipients of Tuition Assistance are required to fill out PaySimple Authorization forms and sign up for auto-pay.

The information contained herein is correct to the best of my knowledge and belief. We understand that TDCA reserves the right to request more paperwork in the future if deemed necessary.
